CONTEXT

The energy transition is set to dramatically transform the global energy sector. It has the potential to eventually shift our global dependence on fossil-based fuels to zero-carbon fuels by the second half of this century. However, mobilizing capital on the scale necessary for this energy transition will require a dramatic increase in the role of the private sector and innovative structures, as well as an enhanced role for the international and development finance institutions that will be critical to catalyzing this investment.

Within this context, the 13th GIF Advisory Council Meeting, "Financing the Energy Transition through Private Sector Participation: Innovations & Opportunities," will explore the rapidly changing landscape of the energy sector. This event will offer participants new insights into the global energy outlook, the private sector's important role in the energy transition, the new trends and technologies that are shaping the energy transition, such as successful green hydrogen transactions and lessons learned from the sector.

In the short term, some countries are relying more on fossil fuels to cushion the economic impact of the shifting energy market. In response to these dynamics, the keynote speaker will explore how the current political economy situation may inspire a lasting transition to clean energy, covering questions such as:

- What major changes to current energy market regulations are necessary for a long-lasting transition?
- Which new climate-neutral technologies should be prioritized (e.g., green hydrogen, biochemicals, or decarbonized materials)?

Session 1: Enabling the Private Sector Role in the Energy Transition

This session will focus on the latest innovations and opportunities for private sector participation in the energy transition agenda. It will provide a high-level overview of available global concessional resources and draw from select public and concessional initiatives that are available to support private capital mobilization, exploring how the private sector can benefit from such initiatives, and discussing their long-term impact and opportunities for replication and scale, covering questions such as:

- What are the existing resources on the concessional side, currently successfully supporting the private capital mobilization at scale?
- What are the observed market trends and the sector(s) attracting the highest amount of private sector participation? What type of innovation and lessons learned could be translated into the less developed sectors?

Session 2: The Green Hydrogen Investment Opportunity

The panel will present successful green hydrogen deals brought to financial close, as well as ongoing opportunities and potential pipelines. Furthermore, industry leaders with extensive transaction experience will present their views on the potential for hydrogen from renewable power to decarbonize the global energy system, and its relevance in different national energy contexts. - What are the key challenges in structuring a bankable green hydrogen transaction?
- What are the ongoing opportunities and potential pipelines to date?
- What are the key hurdles faced by emerging markets looking for ramp up their green hydrogen markets?

DANIEL ZELIKOW

Daniel Zelikow is Vice Chair, Public Sector, at J.P. Morgan, Global Co-Head of Infrastructure Finance and Advisory, and Chair of the Governing Board of J.P. Morgan's Development Finance Institution. In 2020, he launched J.P. Morgan's Development Finance Institution to scale up the firm's financing of development challenges in emerging markets. Immediately prior to re-joining JP Morgan in 2010, Mr. Zelikow was the Executive Vice President and Chief Operating Officer of the Inter-American Development Bank in Washington, D.C. Mr. Zelikow also chaired the management committees on policy, operations, and risk, and he chaired the Board of Executive Directors in the President's absence. Mr. Zelikow was previously with JP Morgan and headed the firm's emerging markets sovereign debt origination and its liability management group. He also managed a New York-based investment banking practice focused on government financial institutions, MDBs, export credit agencies and sovereigns.
